<b>General information</b>	The severity of the symptoms described will vary depending on the concentration and the length of exposure. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing.
<b>Inhalation</b>	Get medical attention. Place unconscious person on their side in the recovery position and ensure breathing can take place. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Get medical attention. Symptoms of lung oedema (shortness of breath) may develop up to 24 hours after exposure. Show this Safety Data Sheet to the medical personnel.

### 5.3. Advice for firefighters

### 6.3. Methods and material for containment and cleaning up

**Methods for cleaning up** No smoking, sparks, flames or other sources of ignition near spillage. Collect and place in suitable waste disposal containers and seal securely. Label the containers containing waste and contaminated materials and remove from the area as soon as possible. If involved in a fire, shut off flow if it can be done without risk. Eliminate all sources of ignition. No smoking, sparks, flames or other sources of ignition near spillage. Provide adequate ventilation. Small Spillages: Absorb small quantities with paper towels and evaporate in a safe place. Large Spillages: Absorb in vermiculite, dry sand or earth and place into containers. ### 7.1. Precautions for safe handling

#### Usage precautions

Avoid contact with skin and eyes. Eliminate all sources of ignition. Keep away from heat, sparks and open flame. All handling should only take place in well-ventilated areas. Dust may form explosive mixture with air. Take precautionary measures against static discharges. Storage tanks and other containers must be earthed. Persons with a history of skin sensitization problems should not be employed in any process in which this product is used.
